

Minutes of Meeting of Sub Committee held at J&KCA Srinagar office

on 17-18 July 2021

The following were present: -

1. Brig Anil Gupta (retd) - Member Administration
2. Sh. Mithun Manhas - Member Cricket
3. Sh. Sunil Sethi - Member Legal

The following points were discussed: -

1. **Passing of Previous Minutes.** Minutes of the sub-committee meeting held on 10 July at Jammu office were passed by all the members.
2. **Nomination for Discussion.** It was decided to invite United Cricket Club Srinagar and District Cricket Association Srinagar for interaction with the Sub-Committee.
3. **Appointment of Travel Agents.** Mr Sunil Sethi informed the Sub-Committee that he is doing the needful and will soon prepare the draft notice for quotations.
4. **Responses Received from Clubs and District Associations.** The Sub-Committee had sought certain information from the Clubs and Associations related to their functioning by 15 July. Member Administration placed before the Sub-Committee the responses received. It was observed by the members that while most of the District Associations have submitted the information sought from them, number of clubs either failed to do so or asked for more time. It was unanimously agreed to grant additional time of one month through a public notice to be published in couple of dailies published from Jammu and Srinagar.
5. **Ombudsman.** The legal advice received from Sh. Rahul Pant, Standing Counsel JKCA was discussed. The standing counsel had opined that continuation of Justice (retd) Syed Bashir ud Din as Ombudsman may be dispensed with since he has exceeded the mandatory three-year period and no dispute is pending. The Sub-Committee as such agreed with the opinion. It was decided to clear all outstanding dues of the Ombudsman and inform him that his services as Ombudsman of JKCA are dispensed with immediately. It was also agreed to appoint a new Ombudsman within one month.



6. **Approval of Accounts of JKCA for month ending June 2021.** Brig Anil Gupta (retd) Member – Administration presented before the Sub-Committee statement of account and the monthly reconciliation statement for June 2021. No discrepancy was observed and after due perusal the accounts were passed.
7. **Pending Payment Request from Sh. Bishan Singh Bedi former Indian Captain and Coach J&K.** In view of differing facts, it was decided to form an in-house committee of those players/ officials who had worked with Bedi Sir during the period claimed by him, ie, from April onwards.
8. **Payment of Arrears of Salary to the Staff of JKCA.** The salary of the staff had been increased by 10% wef 01 January 2020. However, the staff was paid enhanced salary from October 2020 and the arrears for the period 01 January to 30 September were pending. On a request received from the Staff Sub-Committee decided to pay the arrears due to the staff.
9. **Enhancement of Salary of Dvr Firoz.** The said Driver had represented to the Sub-Committee that he was serving with JKCA for almost ten years. However, he is being paid a salary of approx. 12000 per month. There were others who had joined later but were drawing more salary than him. The Sub-Committee perused the salary statement of all employees and decided to enhance the salary of Dvr Firoz to 15000 per month.
10. **JKCA Web Site.** Mr. Mithun Manhas informed that he has contacted the firm which developed the website of DDCA. He said that he was trying to negotiate with the firm to prepare the website of JKCA as well. Mr Mithun Manhas was again authorised by the Sub-Committee to go ahead.
11. **Visit to Ladakh.** As per the directions of the High Court, the Sub-Committee is to ensure promoting of cricketing activities in Jammu and Kashmir as well as in Ladakh. It was therefore decided to visit Leh during week ending 25 July.
