Minutes of the Sub Committee meeting held on 14th April, 2022 at Srinagar

1. The Sub Committee perused and approved the accounts for the month of March, 2022. They also perused the state of CCR's for quarter ending March 2022.
2. **Audit of Accounts:**
Member Administration briefed all the Members and informed them that the pending Mandatory Audit of accounts of JKCA from financial year 2011-12 till financial year 2020-21 has been completed and balance sheets have been prepared. The Sub Committee applauded the good work done by the AHM & CO, Srinagar. Member Administration further briefed that few clarifications needed on the Audit reports submitted by the Auditor have been raised before him for which he will be giving necessary clarifications. It was agreed that to begin with Audit Reports completed for financial year 2011-12, 2012-13 and 2013-14 be sent to BCCI for their perusal. The other balance sheets can thereafter be forwarded.
3. **Release of Festival Allowance:**
The Sub Committee approved to pay the festival allowance at the rate of Rs. 1000 per head to its employees on the occasion of Eid. It was decided to pay the allowance in advance.

4. **Legal Cases:**

Mr. Sunil Sethi, Member Legal Affairs briefed the Sub Committee about the following legal cases:

a. Abdul Rashid V/S JKCA:

Abdul Rashid, employed as driver by JKCA was retired along with the others on attaining the age of 60 years as per the decision taken by the Sub-Committee during its meeting held on 6th March, 2022. However, Abdul Rashid has filed a petition against his retirement in the court of Sub Judge, Srinagar. The application for the vacation of the order will be filed before the next date of hearing which is scheduled on 21st April, 2022.

b. J&K bank has filed an application in the CBI Court to release seized FD's of Ahsan Mirza in their favour. JKCA will file application to intervene and argue the matter.

c. Dr. Farooq Abdullah and Mr. Ahsan Mirza have filed petitions seeking to release their seized properties by ED. JKCA will file application in both cases to claim the properties.

d. Club Matters:

The case is listed on 11th May, 2022. The court will be informed about the consultations held with the disputed clubs of Kashmir. Senior Counsel, Mr. Rahul Pant will be intimated that if the dispute between clubs are not resolved in the High Court, he can then request the High Court to refer all these cases to the newly appointed Ombudsman of JKCA.

e. Aisha Construction V/S JKCA:

The hearing in the said case has begun. Petitioner Counsel has partly argued the case. The next hearing has been fixed on 20th April, 2022. Mr. Rahul Pant will argue on our behalf.

f. Deewakar Sharma VS BCCI:

Draft writ petition has been sent to BCCI for approval. On receipt of the approval of the draft, same will be filed in the Hon'ble High Court of Jammu & Kashmir & Ladakh on behalf of BCCI as well as JKCA.

5. **Domestic Tournament 2022:**

The conduct of Domestic Tournament 2022 was discussed in detail and approved by the members. The following schedule has been approved:

It was also decided that talent hunt team for Ladakh will be sent in the last week of April, 2022 and the talent hunt in remainder zones will commence w.e.f. 06th May, 2022. The Sub-Committee decided to approach BCCI for early release of budgeted amount for the said tournament.

6. **Appointment of Curator:**

The post of curator is lying vacant after the retirement of Mr. Govind Ram and Mr. Ishtaq Ahmad Khan. The application from Mr. Vivek Sharma has been received which was placed before the Sub Committee by Member Administration. After detailed discussion, it was decided to appoint Mr. Vivek Sharma, BCCI qualified Curator on prohibition for 6 months and a monthly salary of Rs. 25,000 plus other existing allowances.

7. **Engagement of CA for Income Tax:**

The Sub Committee approved the appointment of Mr. Altaf Hussain Mir, CA of AHM & CO, Srinagar for the following:

- a. Filing of ITR for Financial year 2020-21
- b. Seek exemption of Income Tax for JKCA from Competent Authority
- c. Reply to Legal Notices received by JKCA from Income Tax Department Srinagar and filing pending returns as needed.
- d. Seek Condonation from Commissioner Income Tax Srinagar for non/late filing of ITR's by JKCA

The Sub-Committee has agreed to pay the following remuneration:

- I. For seeking Exemption on Income Tax – Rs. 1 Lakh
- II. For seeking Condonation – Rs. 50,000
- III. For filing ITR's – Rs. 50,000 per ITR

8. **Sale of Buses:**

Member Administration informed the Sub Committee that he has been informed by Mr. Nikhil Khanna, Manager Finance, BCCI that our proposal for sale of buses has not found favour with the Committee Members of BCCI. As such, the Sub Committee decided to drop the idea of sale of buses. It further decided to hire 20-25 seat buses on requirement basis both at Jammu & Srinagar.



9. **Appointment of Daily Wager Ground Staff:**

The Sub-Committee approved the hiring of Daily wager ground staff as on requirement basis both for Jammu & Srinagar.
