Minutes of the Sub-Committee Meeting held at Srinagar on 24th June, 2022

The following were present:

- Brig. Anil Gupta (Retd.) - Member Administration

The following decisions were taken:

- Brig. Anil Gupta (Retd.) - Member Administration, requested the Sub-Committee to permit him to proceed on a foreign tour to visit his daughter from 19th July, 2022 to 04th October, 2022. The Committee decided that in the absence of Member Administration, regular Video Conference will be held on important issues to take decision. Member Administration assured that he will continue to work from home and attend the office matter regularly despite the fact that there will be a time differentiation of more than 12 hours. It was decided that Mr. Sunil Sethi and Mr. Mithun Manhas will be Co-Signatory for Financial matters related to banking.
- Mr. Mithun Manhas and Brig. Anil Gupta (Retd.) visited the Power Control Room of the JKCA Complex at Sher-E-Kashmir Stadium along with Mr. Majid Dar. The entire set up has been badly damaged due an earlier fire accident and presently the entire system was running on Adhoc basis. It was decided that to avoid any accidents in future, the necessary repairs including re-wiring and replacement of other equipments be undertaken. Mr. Majid Dar was asked to prepare the estimate and submit for approval.
- The pending payment of Azhar Sports was discussed. It was decided that Azhar Sports be asked to submit a fresh GST invoice. The payment of Shah Electrical pending since 2011 was also discussed. It was decided to appoint a Technical Committee to verify on ground the quantum of work done by the said firm. Member Administration was authorized to appoint the Technical Committee.

- iv. Mr. Sunil Sethi, Member Legal briefed the Sub-Committee about the attachment of properties of Mr. Ehsan Mirza, Dr. Farooq Abdullah and Mr. Gazanffar. It was decided that JKCA must apply to the Court to release these properties in its favour.
- v. **Rehab of Mr. Rasikh Salam:**
Rasikh Salam, a Senior player of JKCA was injured while playing in the IPL for Kolkata Knight Riders (KKR). His franchisee was approached to take care of the rehabilitation but it declined. The matter was thereafter forwarded to NCA which agreed to carry out the rehabilitation of Rasikh Salam provided the Association is willing to bear the expenditure. The Sub-Committee took the decision to approach NCA to carry out rehab training of Rasikh Salam as soon as possible and confirm to NCA that expenditure will be borne by the Association.
- vi. It was decided to install Security and Surveillance Cameras both at Jammu and Srinagar offices. Member Administration was authorized to get it installed at Jammu and Mr. Majid Dar was authorized for Srinagar office.
