The following decisions were taken:

- The incentive given by the Association to the Staff has been lapsed on 31st August, 2022. The Sub-Committee has decided to extend the same for the Domestic Season 2022-23 and also with a hike in amount i.e. Rs. 3500 per month.
- Despite repeated efforts with the J&K Bank, there has been no solution on the deductions from the accounts of JKCA by the Bank unauthorisedly. It was decided to lodge an FIR against the bank Officials who have unauthorisedly withdrawn the amount from J&K Bank under the breach of trust. It was decided to file a complaint against Ombudsman of the J&K for the unprofessional conduct of banking business at J&K Bank. The Sub-Committee also explores the possibility to file before the consumer forum against the J&K Bank for claiming that amount unauthorisedly withdrawn and the penalty and the interest given.
- The Sub-Committee decides to hold practice camps for U-19 Men & Senior Men at Sher-e-Kashmir Stadium Srinagar and U-19 Women & Senior Women at Hostel Ground Jammu.
- The Sub-Committee decides to discontinue the Services of CA Altaf Ahmed Mir AHM Corporation because of the unprofessional and non-cooperating conduct on his behalf. The Sub-Committee decides to presently have the services of Gupta Sharma Associates as CA.
- The Sub-Committee decides to submit the revised Cricket Infrastructure budget to Board of Control for Cricket in India (BCCI) and the Administrative Infrastructure budget for the year 2022. The Said budget have been seen and discussed by the Sub-Committee and approved for submission to BCCI.
