MINUTES OF THE SUB-COMMITTEE MEETING HELD AT JAMMU ON 25th FEBRUARY, 2023

The following were present:

- a. Brig. Anil Gupta (Retd.) – Member Administration
- b. Sh. Sunil Sethi – Member Legal Affairs
- c. Sh. Mithun Manhas – Member Cricket Operations & Development

1. The following decisions were taken:

- a. To hire 04 Groundsmen on contractual basis locally for JKCA Complex, Jammu.
- b. The DA to JKCA Office employees for movement within UT will be paid @ Rs. 1000 per day w.e.f. 01st January, 2023.
- c. Mr. Vivek Sharma, Curator whose services were extended till the completion of national matches will be relieved and his services terminated w.e.f. 01st March, 2023.
- d. On termination of the services of present curator, Mr. Vivek Khajuria to be appointed as Incharge Nets and Grounds at JKCA Complex, Jammu, w.e.f. 01st March, 2023.
- e. An amount of Rs. 1,28, 568 due from Mr. Rajesh Dhar since 2018-19 to be recovered from his contract fee in case he does not deposit the said amount before that in the given account of JKCA.
- f. The Office furniture at JKCA complex, Jammu which needs repairs should be repaired at the earliest.
- g. The Sub-Committee perused the damage taken place due to short circuit at JKCA Complex on 20th January, 2023. An amount of Rs. 1, 54, 0000 spent on repairing of damaged infrastructure was approved. The list of damaged items with cost of repair is attached.

- h. The Sub-Committee approved the requirement of hiring fresh auditors for the FY 2022-23 and authorized Member Administration to appoint RBI approved Auditor for Statutory Audit of FY 2022-23.
- i. Re-engagement for a period of six months of Mohd. Abdullah, retired groundsman, on contractual basis as recommended by Mr. Majid Dar, I/c Cricket Development, Kashmir, was approved.

2. IDENTIFICATION AND PREPARATION OF NEW GROUNDS:

After discussion the Sub-Committee decided to negotiate with the concerned for establishing grounds (turf wickets) at the following places:

- a. SKAUST, R.S. Pura
- b. Khel Gaon, Nagrota
- c. SMVDU, Katra
- d. JK Police Academy, Udhampur

It was decided that the Sub-Committee will visit these places as early as possible and after discussing with the concerned authorities, sign MOU's for development of these grounds. Mr. Sunil Sethi, Member Legal was requested to pursue the case of Cricket Stadium at Bhagwati Nagar, Jammu with the Divisional Commissioner, Jammu.

3. ANALYSIS OF PERFORMANCES OF TEAMS:

The performance of the JKCA teams during the season 2022-23 was discussed at length. Each team performance was analyzed including the contribution of the Coaches. The Sub-Committee members also felt that there needs to be consistency in selection of the teams by the Selection Committees. After a detailed analysis, a roadmap was prepared for the better performance of teams during next season. The following was decided:

- a. Establishment of JKCA Cricket Academies at Srinagar and Jammu.
- b. To hold Talent Hunt 2023 only for U-14 Boy's, U-15 Girl's, U-16 Boy's, U-19 Boy's and U-19 Girl's [Junior Age Groups].
- c. To organize physical fitness camps for Senior and Junior Women's Teams.
- d. To organize specialized camps for batting, bowling and fielding for the teams.

- e. To organize Domestic tournaments for our senior teams both Men & Women. Explore the possibility of the teams participating in tournaments conducted by other Associations.

4. ESTABLISHMENT OF JKCA CRICKET ACADEMY:

With the preparation of new wickets including practice wickets both at Jammu & Srinagar, we are now in a position to start regular practice for our Registered players and for new talent (young cricketers). It was decided to appoint one male and female coach each both at Jammu & Srinagar as well as one Physiotherapist and Trainer each at both the places. After the appointment of the staff, regular practice session will be held under the aegis of JKCA Cricket Academy both at Jammu & Srinagar.

5. APPEAL AGAINST THE DECISION OF OMBUDSMAN IN J&K BANK CASE:

Mr. Sunil Sethi, Member Legal advised that we should instantly file case at Consumer Court, Srinagar. He was authorized to proceed further in the case.

6. ANNUAL SALARY HIKE OF JKCA STAFF:

The last hike was done in April 2021. It was decided that the salary of JKCA staff be hiked by 10% w.e.f. 01st April, 2023.

7. VISIT OF SECRETARY, BCCI:

Member Administration briefed the other members about the proposed visit of the Secretary, BCCI. The confirmed dates of visit are still awaited. The members felt that the visit of Secretary, BCCI will give a boost to JKCA, and welcomed the same

8. PROVISION OF GYMNASIUM AT JAMMU/ SRINAGAR:

Our players suffer due to non availability of proper gymnasium at both Jammu & Srinagar. A request for release of fund for establishment of same has been sent to the BCCI but the
