INSTRUCTIONS FOR SELECTION, TRAINING AND DISPATCH OF JUNIOR WOMEN TEAM TO REPRESENT I&K IN U-19 WOMEN'S T20 TOURNAMENT NATIONAL CHAMPIONSHIP CONDUCTED BY BCCI 2024-25

- 1. U-19 Women's T20 National Championship is being held from 01st October, 2024 to 18th October, 2024. The tournament will be organised in two phases as follows:
 - a) Phase-I League Matches.
 - b) Phase-II Knockout Matches.
- 2. J&K team is placed in Elite Group C along with Hyderabad, Punjab, Meghalaya, Uttrakhand and Kerala.
- 3. Venues:
 - a) League Matches -01st October, 2024 to 08th October, 2024 at Rajkot.
 - b) Knockout Matches 12th October, 2024 to 18th October, 2024 at Haryana.

- Transport Tempo travel will be used for the movement of players from Jammu to Katra and vice versa.
- **8.** The Umpires and scorers for matches, if played during the camps will be detailed by the Office. The same will be detailed after getting the approval from the Sub-Committee. The Umpire will be paid @Rs. 1000 per match day and Scorer will be paid @Rs. 800 per match day.
- **9.** DA @Rs. 1000 per camp day will be paid to the Support Staff. The Players & Support Staff will be paid @Rs. 1500 per day as DA for duration of the main tournament including travel dates.
- **10.** Lunch will be provided on all days. The first-aid box and mineral water in jars will also be provided.
- **11.** A daily attendance report will be submitted by the Manager to the Cricket Operations Section & Member Administration. The manager will also submit the details of attendance of support staff as per below format before team's departure for **the National Tournament.**
