INSTRUCTIONS FOR SELECTION, TRAINING AND DISPATCH OF SENIOR MEN
TEAM TO REPRESENT J&K IN RANJI TROPHY TOURNAMENT NATIONAL CHAMPIONSHIP CONDUCTED
BY BCCI 2024-25 (PHASE II)

1. Ranji Trophy Phase II National Championship is being held from 23rd January, 2025 to 02nd March, 2025.
2. J&K team is placed in **Elite Group A** and is yet to play the matches against **Mumbai and Baroda in Phase II.**
3. Venues:-
 - a) League Matches - 23rd January, 2025 to 02nd February, 2025 at Mumbai & Vadodra.
 - b) Knockout Matches - 08th February, 2025 to 02nd March, 2025 at Home/Away Venues
4. Duration:-
 - a) League Matches as per following schedule:

5. To select and prepare the J&K Team for the tournament a preparatory camp will be held at Hostel Ground w.e.f. 11th January, 2025 to 15th January, 2025. The Outstation players and Members of Support Staff will report at Jammu on 10th January, 2025.

On 16th January, 2025, the team will travel to Mumbai for Pre Tournament practice.

At Mumbai the team will have practice sessions at Air India Ground as per the following schedule:



- 17 Jan 2025 to 19 Jan 2025 - 2 Nets will be available w.e.f. 9:30 am to 12:00 pm & 3:30 to 6:00 pm.
- On 20th January, the session will be held at BKC from 8 am to 10 am.
- Snacks @75 per head can be arranged after the practice sessions, The manager will liaise directly with Mr. Tanuj for catering at Air India ground.

7. **Administrative Arrangements:-**

- Accommodation** – The Outstation players and Members of Support Staff will be accommodated in Hotel Inn Riveria, Jammu and the team will be accommodated in Hotel Aurika by Lemon Tree, Mumbai.
 - Transport** –Tempo Traveller will be used for the movement of Players and Support Staff from Hotel to ground and vice versa. NO separate transport will be hired for Support Staff during the camps.
The transport at Mumbai will be hired from 17th Jan to 20th Jan. MCA will provide transport on 16th January for drop to the Hotel from the Airport and from 21st Jan onwards.
- The Umpires and scorers for practice matches, if to be played during the camps will be detailed within the Members of Support Staff.
 - DA @Rs. 1000 per camp day will be paid to the Support Staff. The Players & Support Staff will be paid @Rs. 1500 per day as DA for duration of the main tournament including travel dates.
 - Lunch will be provided on all days. The first-aid box and mineral water in jars will also be provided.



11. A daily attendance report will be submitted by the Manager to the Cricket Operations Section & Member Administration. The manager will also submit the details of attendance of support staff as per below format before team's departure for **the National Tournament**.

12. Instruction for Video Analyst:

No picture or video clips will be provided to the players or any media house directly by the Video Analyst. The same will be submitted everyday to the Cricket Operations & Development Section under information to the Member Cricket Operations & Development and Member Administration.

13. Submission of Match Fee Indents:

It will be the responsibility of the Manager to brief all the players to file the Match Fee Indent online directly by each player on the BCCI portal. In case of any clarification same should be obtained by the Manager from the Accounts Section.

The entire process is to be completed by each player within 15 days of the last match played by the team.
