# INSTRUCTIONS FOR SELECTION, TRAINING AND DISPATCH OF WOMEN TEAM TO REPRESENT J&K IN U-23 WOMEN'S OD TOURNAMENT NATIONAL CHAMPIONSHIP CONDUCTED BY BCCI 2024-25

- U-23 Women's OD National Championship is being held from 05th March, 2025 to 26th March, 2025. The tournament will be organised in two phases as follows:
  - a) Phase-I League Matches.
  - b) Phase-II Knockout Matches.
- 2. J&K team is placed in Elite Group B along with Jharkhand, Uttar Pradesh, Mizoram, Goa and Karnataka.
- 3. Venues:
  - a) League Matches -05th March, 2025 to 13th March, 2025 at Trivandrum.
  - b) Knockout Matches 17th March, 2025 to 26th March, 2025 at Guwahati.

#### 4. Duration:-

a) League Matches from 05th March, 2025 to 13th March, 2025 as per following schedule:

- 5. To prepare the J&K Team for the tournament, a preparatory camp will be organised at 17 Miles Ground, Vijaypur w.e.f. 17th February, 2025 to 23rd February, 2025. The outstation players and the Members of the Support Staff will report at Jammu on 16th February, 2025. latest by 17:00 hrs. The team will travel to Trivandrum on 24th February, 2025 for pre tournament practice.

#### 7. Administrative Arrangements:-

 a) Accommodation – The outside players and support staff will be accommodated at Hotel Sheela Resorts, Talab Tillo, Jammu.

The team will be accommodated in **Hotel Karthika Park, Kazhakoottam** during the pre tournament practice and the tournament.

#### b) Transport -

- The Players and Support Staff from Kashmir region will report at Jammu under the arrangements of JKCA Office, Srinagar. Preferably tempo traveller will be hired.
- JKCA bus will be used for the movement of players from MA Stadium to Ground and Vice versa. Since the Hotel is in city area and bus cannot enter the area, tempo traveller will be used for the movement of players from Hotel to the MA Stadium.
- **8.** The Umpires and scorers for matches to be played during the camps will be detailed within the members of Support Staff.
- 9. DA @Rs. 1000 per camp day will be paid to the Support Staff. The Players & Support Staff will be paid @Rs. 1500 per day as DA for duration of the main tournament including travel dates.
- 10. Lunch will be provided on all days. The first-aid box and mineral water in jars will also be provided.



- **11.** The final list will be submitted on 17th February, 2025 to the Cricket Operations & Development Section.
- 12. The departure date of the team will be 24th February, 2025.
- 13. A daily attendance report will be submitted by the Manager to the Cricket Operations Section & Member Administration. The manager will also submit the details of attendance of support staff as per below format before team's departure for the National Tournament.

#### 14. Instruction for Video Analyst:

No picture or video clips will be provided to the players or any media house directly by the Video Analyst. The same will be submitted everyday to the Cricket Operations & Development Section under information to the Member Cricket Operations & Development and Member Administration.

#### 15. Submission of Match Fee Indents:

It will be the responsibility of the Manager to brief all the players to file the Match Fee Indent online directly by each player on the BCCI portal. In case of any clarification same should be obtained by the Manager from the Accounts Section.

The entire process is to be completed by each player within 15 days of the last match played by the team.
