RESOLUTION BY CIRCULATION OF THE APEX COUNCIL

Subject: Interim Suspension of the President and Reference of Matter to the Ombudsman

a. WHEREAS, material has been placed before the Apex Council disclosing serious allegations against Shri Javid Ahmed Kitab, President, Jammu & Kashmir Cricket Association, which, prima facie warrant consideration including inter alia, that:

- (i) he furnished an incorrect date of birth at the time of filing his nomination to the office of President, thereby necessitating verification of the authenticity of the documents relied upon by him;
- (ii) he, in a video, has publicly stated that orders are drafted by him and that the Presiding Officers of the Court merely append their signatures thereto, which statement, if made, has the tendency to undermine public confidence in the independence and integrity of the judicial system and is wholly inconsistent with the standards of propriety expected from the President of the Association;

(iii) he has, by his acts and omissions, adversely affected the functioning of JKCA, resulting in disruption of its administration, delay in release of salaries of employees and impediments in the smooth conduct of cricketing activities;

(iv) made statements in a video which are alleged to be communal in nature and inconsistent with the values, objectives and ethos of the Association;

(v) he has repeatedly deferred, obstructed and frustrated the convening and functioning of meetings of the Apex Council and other statutory bodies without lawful justification, thereby impairing the governance of the Association;

(vi) he has attempted to influence appointments, nominations and constitution of committees by insisting upon inclusion of persons of his choice, contrary to the procedure prescribed under the Constitution of JKCA;

(vii) he has indulged in acts of indiscipline, misconduct and abuse of the office of President, prejudicial to the interests, harmony, integrity and reputation of the Association; and

(viii) he has acted in disregard of the Constitution of JKCA by attempting to convene meetings and undertake actions contrary to its provisions, thereby frustrating the constitutional scheme governing the affairs of the Association.

b. AND WHEREAS, upon consideration of the material placed before it, the Apex Council is satisfied that the aforesaid allegations disclose a prima facie case warranting independent inquiry and adjudication, and that the continued discharge of the functions of the office of President by Shri Javid Ahmed Kitab during the pendency of such proceedings is likely to impede a fair inquiry, adversely affect the administration of the Association and prejudice its institutional interests;

c. AND WHEREAS, the Apex Council, in exercise of its powers under Rule 23(i) of the Constitution of JKCA to take decisions by circulation, and being responsible for the governance and management of the affairs of the Association, considers it imperative to adopt appropriate interim measures to preserve the integrity of the Association, ensure continuity of its administration and uphold the rule of law pending adjudication of the allegations;

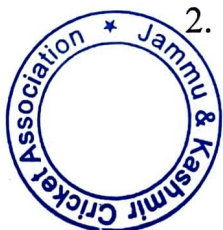

NOW, THEREFORE, IT IS HEREBY RESOLVED AS FOLLOWS:

1. Shri Javid Ahmed Kitab, President, Jammu & Kashmir Cricket Association, is hereby placed under interim suspension from exercising or discharging any of the powers, functions or responsibilities attached to the office of President, with immediate effect, pending adjudication of the allegations against him.



2. The aforesaid allegations, together with all documents, electronic records and other material received by the Association, shall forthwith be referred to the Ombudsman for independent inquiry and adjudication in accordance with the Constitution of JKCA.

3. The Ombudsman will be requested to examine the allegations, afford reasonable opportunity of hearing to all concerned, and pass such orders as may be deemed fit and proper under the Constitution of JKCA.

4. During the period of interim suspension, the affairs of the Association shall continue to be administered by the Apex Council in accordance with the Constitution of JKCA, and all officers, employees, committees and stakeholders of the Association shall continue to function under its lawful directions to ensure that the administration of the Association and cricketing activities remain uninterrupted.
