### CALL FOR QUOTATIONS

#### AUCTION OF IRON SCRAP AT S K STADIUM SRINAGAR

The Jammu & Kashmir Cricket Association (JKCA) invites sealed Quotations from interested parties for the purchase of iron scrap at SK Stadium, Srinagar, through auction. This would involve dismantling of existing stands and removing the iron bars as scrap.

Interested bidders may inspect the stands at SK Stadium, Srinagar, during working hours before submitting their bids.

#### Terms & Conditions

1. The iron stands shall be sold on an "as is where is" basis.
2. Interested bidders are advised to inspect the stand at SK Stadium, Srinagar, prior to submission of their bids. No claim regarding the quantity, quality, condition or nature of the stand shall be entertained subsequently.
3. The bid quoting the highest rate per kg /amount shall be considered for acceptance, subject to the approval of the Competent Authority.
4. The successful bidder shall be solely responsible for the dismantling, loading, lifting, removal and transportation of the scrap from the site, at their own cost, risk and responsibility.
5. The loaded truck /(s) will be taken to a Weighing Bridge and weighed in the presence of a JKCA Rep and Rep of the Contractor. The weight slip issued by the Weighing Bridge will be signed by both the reps and handed over to JKCA Rep for depositing with Adm Officer, Srinagar Office JKCA who will be responsible for its safe custody.
6. All applicable taxes, duties, levies, charges and other statutory liabilities, if any, arising out of the auction shall be borne entirely by the successful bidder.
7. The successful bidder shall deposit a security deposit of Rs 3 ( three) lakh in the account of JKCA before the commencement of lifting the scrap. This amount will be adjusted against the total amount payable by the bidder. At the end of dismantling of each stand, full payment due till then will be made by the successful bidder before lifting from the next
