NOTIFICATION

1. Whereas, the Apex Council of the Jammu & Kashmir Cricket Association, in exercise of its powers under Rule 23(i) of the Constitution, has, by Resolution passed by circulation on 25.06.2026, placed Shri Javid Ahmed Kitab, President, JKCA, under interim suspension from exercising or discharging the powers, functions and responsibilities attached to the office of President with immediate effect, pending inquiry and adjudication by the Ombudsman;
2. And whereas, the said Resolution further provides that the affairs of the Association shall continue to be administered in accordance with the Constitution of the Jammu & Kashmir Cricket Association so as to ensure continuity of administration and the uninterrupted conduct of the affairs of the Association;
3. And whereas, during the continuance of the aforesaid interim suspension, the President is unavailable to discharge the duties and functions attached to his office;
4. And whereas, Rule 15(b) of the Constitution provides that the Vice President shall officiate in the President's absence whenever the President

is unavailable and shall exercise such functions and duties as may be entrusted under the Constitution;

5. Now, therefore, in consequence of the Resolution dated 25.06.2026 and in terms of Rule 15(b), read with Rules 22 and 23(i) of the Constitution of the Jammu & Kashmir Cricket Association, it is hereby notified that Shri Desh Rattan Dubey, Vice President, shall, with immediate effect, officiate as President of the Jammu & Kashmir Cricket Association and shall exercise and discharge all powers, functions and responsibilities attached to the office of the President in accordance with the Constitution, subject to the decision of ombudsman or for a period of six months whichever is earlier.
6. Accordingly, all Office Bearers, Councillors, Committees, employees, affiliated units, officials and all persons dealing with the affairs of the Association shall recognise and act upon the authority of the Vice President officiating as President and shall extend full cooperation in the discharge of his constitutional functions.
7. This Notification shall come into force with immediate effect.
