RESOLUTION

1. Whereas, the Apex Council of the Jammu & Kashmir Cricket Association, in exercise of its powers under Rule 23(i) of the Constitution, has, by Resolution passed by circulation on 25.06.2026, placed Shri Javid Ahmed Kitab, President, JKCA, under interim suspension from exercising or discharging the powers, functions and responsibilities attached to the office of President with immediate effect, pending inquiry and adjudication by the Ombudsman;
2. AND WHEREAS, Rule 23(i) of the Constitution of the Jammu & Kashmir Cricket Association empowers the Apex Council to take such interim measures as may be necessary in the interest of the Association, subject to adjudication by the Ombudsman;
3. AND WHEREAS, Rule 15(b) of the Constitution provides that the Vice President shall officiate in the President's absence whenever the President is unavailable and shall discharge such duties and functions as are assigned under the Constitution.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

1. In terms of Rule 15(b), read with Rules 22 and 23(i) of the Constitution, Shri Desh Rattan Dubey, Vice President, shall officiate as President of the Jammu & Kashmir Cricket Association and shall exercise and discharge all powers, functions and responsibilities attached to the office of the
